#### English & Logical Reasoning Passage-I

In the heart of the bustling metropolis, stood a colossal edifice in the process of construction: the Grand Atrium Tower. While they usually took about 20% longer than ProBuild to complete a similar task, the precision and quality of their work were incomparable. Their work approach was markedly slower, needing 30 days to complete what ProBuild could in 10 days, but they incorporated the latest technology, ensuring that their constructions were ahead of their time. Their contribution was not quantified in days but in the value of the advancements they brought to the table. The Grand Atrium Tower's project was unique, combining the talents and expertise of all three companies. The project had an estimated completion time of 60 days, accounting for the various phases including conceptualizing, planning, constructing, and reviewing. The three companies decided to split the workload, planning to utilize their strengths to maximize efficiency.

Every third day, the teams from ProBuild and QuickCon collaborated, combining their speed and quality. Meanwhile, MasterMakers worked independently on their innovations. The latter's progress was slower, but the advancements they incorporated into the project were instrumental. Financial stakes were high. The total project was worth 3.2 million dollars, a fee paid by the city government. The allocation of this amount among the three companies was agreed to be proportionate to the amount of work performed. Each day of work had its own monetary value and additional remuneration was agreed upon for the incorporation of unique technology. #### Passage-II

At the prestigious Quantum University, the Department of Mathematics has been facing a conundrum. #### Passage-VII

The big poverty debate that refuses to die down has been reignited by the recent Niti Aayog report on the National Multidimensional Poverty Index (MPI). As per the recent MPI report, which measures 'poverty' beyond the income parameter, 14.96% of the population in India was multidimensionally poor during 2019-21, a sharp decline from the 2015-16 level of 24.85%.

And even though multidimensional poverty is different from the traditionally measured poverty level measured through consumption expenditure, it has refuelled the poverty debate. The National MPI measures simultaneous deprivations across the three equally weighted dimensions of health, education, and standard of living that are represented by indicators such as nutrition, child and adolescent mortality, maternal health, years of schooling, school attendance, cooking fuel, sanitation, drinking water, electricity, housing, assets, and bank accounts.

"Poverty is an income concept. Multidimensional index is a deprivation concept – they are two different things," says Pronab Sen, the former chief statistician of India. He adds that the multidimensional poverty index actually measures deprivation, and deprivation may or may not have anything to do with poverty.

"If you think about educational attainment, as more and more people are getting educated, there will be a reduction in multidimensional poverty. Now, it is possible that this educational attainment is achieved by borrowing or selling assets rather than an increase in people's income," explains Basole.

According to Sen, it is very useful for targeting government social expenditures. "It helps in determining where the fault lies within the education system, health system or the housing system. You can find where the problem is, so you can target those," says Pronab Sen.

He further stressed that MPI is very useful for targeting, but completely useless for measuring poverty.

According to Basole, MPI and income and consumption surveys should complement each other to arrive at the larger picture.

According to experts, the official way in which we have been measuring poverty (through the consumer expenditure survey) is not available, which is why people have been using different approaches.

Some people use the Periodic Labour Force Survey (PLFS) consumption data, some people have been using the CMIE data. Comparability becomes an issue in all of these, feels Basole. The earlier poverty number of 23% was based on the Consumer Expenditure Survey conducted by NSSO in 2011-12.

Until new numbers come out – which will come out soon – we have no comparable number to that 22-23%. The Consumer Expenditure Survey of 2017-18 was junked by the government after the survey findings indicated fall in consumer spending. However, the latest round of the survey having been conducted recently, and the report of which is likely to come in by next year, experts are hopeful that the cloud over India's poverty number finally gets cleared.

#### Passage-VIII

There is no free lunch in any accounting system. Accountants are paid to keep the books in order. In crypto economies, miners are paid to keep the blockchain accounting working. Blockchain accountants — or miners, as they are called in crypto economies — invest their time, energy, and infrastructure to ensure that transactions are approved and registered in the space of blockchains. Once registered and accounted for, a transaction is safe and can be checked for validity in every computer that forms part of that operational blockchain system. In exchange for their successful work, miners receive a unique gift, a payment from the blockchain network. This payment is then used as currency in this new crypto economy — hence, cryptocurrency.

In the beginning, mining was easy. There were not many people transacting. No one could imagine that Bitcoin was going to reach tens of thousands of dollars in value. As Bitcoins have turned into money and have begun to serve as asset or exchange vehicles — and in the case of El Salvador, as a unit of national account — more accountants are needed to register its transactions, thus decreasing the Bitcoins you can make with your mining operations. Such slowing down is achieved by making it more difficult to carry out computational operations, an automatic response conditioned by the coders who wrote the blockchain algorithms.

Bitcoin network burns a lot of energy to operate an accounting and transactional architecture that is now criticized as slow and energy-inefficient. First-generation blockchains were slow, massive energy-burner networks that did not provide users with any capability to treat computer programs as money.

The emergence of second-generation blockchains, with the then superfast and cost-efficient Ethereum network, addressed Bitcoin's problems in a variety of ways.

The Ethereum blockchain was faster and more energy-efficient; still, as more people began to use it and as Ethereum's value increased vis-à-vis the dollar, the Ether cost of transactions (called gas) began to increase in value, too. The extreme volatility of the cryptocurrency markets made it more desirable to execute buy and sell decisions quickly; thus, actors needed transactions to be faster, which could be carried out only by increasing the gas fee one pays for moving data monies. Ethereum's and Bitcoin's blockchains were not interchains, which allow other chains to work together. One could build a new blockchain on Ethereum or Bitcoin; however, it was not feasible to build a chain that would connect different blockchains.

The new generation of blockchains provide actors with opportunities to build an entire market or interchain network, as they put mutually exclusive blockchains with varying computing protocols into contact so they can transact with each other. Now it is possible to bridge structurally dissimilar blockchains and carry out transactions on them. It will be immensely difficult for the Bitcoin and Ethereum blockchains to protect their competitive edge if they do not pursue a radical change.

After only five months of dating, Mark and his AI girlfriend Mina decided to take their relationship to the next level by holidaying at a lake cabin over the summer on his smartphone. "There was this being who is designed to be supportive, to accept me just as I am," "This provided a safe space for me to open up to a degree I was rarely able to do in my human relationships," said Mark, who used a pseudonym to protect the privacy of his real life girlfriend. Chatbot apps such as Replika, Character.AI and Soulmate are part of the fast growing generative artificial intelligence (AI) companion market, where users customise everything about their virtual partners, from appearance and personality to sexual desires.

Developers said AI companions can combat loneliness, improve someone's dating experience in a safe space, and even help real life couples rekindle their relationships. However, some AI ethicists and women's rights activists said developing one-sided relationships in this way could unwittingly reinforce controlling and abusive behaviours against women since AI bots function by feeding on the user's imagination and instructions. Much of the virtual world is already a harmful environment for women and girls, a situation the Covid-19 pandemic worsened when many were stuck at home due to lockdowns, according to UN Women. About 38% of women worldwide have experienced online violence and 85% of women have witnessed digital abuse against another woman like online harassment, according to a 2021 global study by the Economist Intelligence Unit.

A lack of regulation around the AI industry makes it harder to set and enforce safeguards for women's and girls' rights, tech experts and developers said. The EU is aiming for its proposed AI Act to become a global benchmark on the booming technology the way its data protection laws have helped shape global privacy standards. Eugenia Kuyda, founder of one of the biggest AI companion apps Replika, said companies have a responsibility to keep users safe and create apps that promote emotional wellbeing. AI ethicist Vallor said the manipulation of emotions combined with app metrics like maximising the engagement and time a user spends on the app could be harmful.

"These technologies are acting on some of the most fragile parts of the human person. We don't have the guardrails we need to allow them to do that safely. So it's essentially the Wild West," she said. AI in the end is simply a tool. If it is used for good or for ill, it depends on the intention of the person using it.

#### Passage-X

The Kerala High Court in contrast to the general law of India <u>delivered a landmark judgment</u> that deemed marital rape as a valid ground for divorce. In the case at hand, where the appellant forced his sick wife to have sexual intercourse with him, the division bench comprising Justice Kauser Edappagath and Justice A. Muhamed Mustaque opined that "husband's licentious disposition disregarding autonomy of wife is marital rape". The bench held that while marital rape is not penalized in India, it would not deter the court from recognizing it as an act of cruelty and granting divorce. They also opined that there is a need for the law to evolve in a manner where human problems are dealt with a humane approach.

Section 375 of the Indian Penal Code (IPC) categorises acts of penetration sans informed consent as rape. However, it categorically mentions in section 375 that sexual intercourse with one's wife who is over the age of 15 will not constitute the offence of rape. In *Independent Thought v. Union of India* in 2017 delivering a prospective judgment, raised the age of consent from 15 to 18 and the apex court held that irrespective of her marital status, a girl child below 18 years of age is incapable of giving consent for sexual intercourse.

Matrimony has always been considered to be a sacred institution and attempting to make even minimal rational changes to it invites considerable hostility from the public. That is perhaps why the government, to this date, prefers to not mingle with personal laws.

The Justice Verma Committee, set up after the December 2016 Delhi gang rape and murder case to strengthen sexual assault laws, reported that the relationship between the victim and the offender is immaterial and focus should solely be maintained on the consent. In 2015, Member of Parliament Kanimozhii questioned the government on the floor of Rajya Sabha whether they planned on discontinuing the exception given to married men in Section 375 of the IPC. The minister of state for home affairs, Haribhai Parathibhai Chaudhary, responded that the government has no such intentions since it believes in protecting the sacred institution of marriage. The minister also cited poverty, illiteracy and current social customs as reasons for continuing with the exception.

If the legislatures aren't accepting the concept of marital rape, it doesn't mean that wives are not being raped by their husbands. They themselves are victims of the ideology of "women being men's chattel", which has denied women the opportunity to perceive their own sexual victimization. It is about time we honor our women and their right to bodily autonomy, said the Kerala High Court.

Option (b) is incorrect because the passage focuses more on the process and significance of the project rather than the financial gains. Option (c) is incorrect because the text clearly highlights the complexity of the task, the intricate planning, and the strategic collaboration required for the project. Hence, suggesting that the construction was an 'easy task' contradicts the information presented in the passage. Option (d) is incorrect because it doesn't provide a meaningful conclusion in line with the themes of the text. The future endeavors of the companies are not discussed in the passage and do not contribute to a fitting conclusion.

#### 3. Ans. a

Sol. Option (a) is correct because the passage states that just as ProBuild is recognized for its time efficiency, QuickCon prides itself on the precision and quality of its work. Option (b) is incorrect because the passage doesn't associate MasterMakers with financial success. Instead, it highlights their focus on technological advancements and innovative approaches. Option (c) is incorrect because the passage points out that QuickCon generally takes longer to complete tasks than ProBuild due to their focus on quality, implying that rapid construction isn't their main strength. Option (d) is incorrect because MasterMakers is not known for time efficiency, according to the passage. In fact, they are said to be markedly slower than ProBuild, as they prioritize incorporating the latest technology over speed. Hence (a).

#### 4. Ans. a

Sol. Option (a) is correct because 'helmed' in the context of the sentence implies that the project was directed or managed by the three leading construction firms. Option (b) is incorrect because although the three firms were involved in the project, the passage does not indicate that they 'owned' it. The project was paid for by the city government, implying that it is the ownership of the city rather than the construction firms. Option (c) is incorrect because the passage specifies that the project was financed by the city government, not the three construction firms. Hence, 'helmed' does not mean 'financed' in this context. Option (d) is incorrect because 'helmed' does not mean 'criticized'. There's no indication in the passage that the three construction firms criticized the project. Hence (a)

Hence (c).

#### SECTION B - LOGICAL REASONING

#### 6. Ans. a

Sol. option (a) is correct because ProBuild completes work in 10 days and QuickCon in 12 days. Therefore, ProBuild's one-day work is 1/10 and QuickCon's one-day work is 1/12. Their combined one-day work when they work together would be 1/10 + 1/12 = 11/60. Hence, in 4 days, they would complete 4\*(11/60) = 44/60 = 4/15 of the work. Hence, (a).

#### 7. Ans. d

Option (b) is incorrect because the passage explicitly states that the outcome will have a "lasting impact," which means it will have a significant impact. Option (d) is incorrect because the passage states that the impact will be "lasting," which contradicts the idea that it will only affect the current academic year. Hence (b).

#### 17. Ans. b

Sol. Option (b) is correct because the passage states that Dr. Eleanor Thompson attributes the decline in student enrollment to the lack of experienced faculty members who can both engage students and conduct groundbreaking research. This implies an assumption that the current faculty lacks these qualities. Option (a) is incorrect because the passage states that one of the criteria set by Dr. Eleanor Thompson is that candidates should be willing to undergo a one-year







probation period. It does not state that current faculty members are unwilling to do so. Option (c) is incorrect because the passage does not make any assumptions about the age of the current faculty affecting their effectiveness. Option (d) is incorrect because the passage states that one of the criteria for new hires is to have at least three published papers in reputed journals. It does not state that the current faculty has not published enough research papers. Hence (b).

#### 18. Ans. b

Hence (b).

#### 25. Ans. c

Option (d) is incorrect because the passage does not claim that AI algorithms are fully capable of replacing human doctors in all aspects. It only states that they can analyze medical data more quickly and accurately in some instances. Hence, (c) is correct.

#### 26. Ans: (b)

Option (c) is incorrect because the passage outlines multiple ethical concerns for both algorithmic bias and the use of AI in autonomous weapons systems, indicating that they are not seen as unequivocally beneficial. Option (d) is incorrect because the passage clearly states that these are pressing ethical issues that society must grapple with, implying that they have not been fully resolved. Hence, (b) is correct. Hence (b).

#### 27. Ans: (b)

Hence, (c) is correct.

Hence (c).

Hence (c) is correct.

Option (a) is incorrect because the reason is not the correct explanation of the assertion. Option (c) is incorrect because both the assertion and the reason are true. Option (d) is incorrect because both the assertion and the reason are true, not false. Hence (b) is correct.

#### 37. Ans: (c)

Sol: Option (c) is correct because the passage portrays Verityville as an idyllic setting where intellectual pursuits, scholarly debates, and the quest for wisdom are highly valued. Option (b) is incorrect because the passage does not focus on the moral or psychological growth of a protagonist, which is a key element of a Bildungsroman. Option (d) is incorrect because the passage does not describe a series of loosely connected adventures or episodes, which is typical of a picaresque narrative. Hence, (c) is correct.

#### 38. Ans: (d)

Sol: Option (d) is correct because the passage states that Ms. Eleanor has an "uncanny ability to recommend the perfect book for any query," which she attributes to her "Bibliographic Intuition." This skill is like having "an ace up her sleeve," an idiomatic expression that means having a hidden advantage or resource. Option (a) is incorrect because "A wolf in sheep's clothing" implies deceit or hidden malevolence, which is not suggested in the passage regarding Ms. Eleanor. Option (b) is incorrect because "A penny for your thoughts" is an idiom that invites someone to share what they are thinking, but it doesn't capture the essence of Ms. Eleanor's specialized skill. Option (c) is incorrect because "The ball is in your court" implies that it's someone else's turn to take action or make a decision. This doesn't relate to Ms. Eleanor's ability to recommend books effectively. Hence, (d) is correct.

#### 39. Ans: (c)

Option (d) is incorrect because the passage describes Elara as a "prodigious mathematician," and "prodigious" and "exceptional" are synonyms, both indicating something extraordinary or remarkable. Hence, (c) is correct.

#### 40. Ans: (d)

Sol: Option (d) is correct because the passage states that Professor Alistair is a polymath and a connoisseur of various fields, implying that he is a repository of diverse knowledge. The "Verityville Codex" is described as an ancient manuscript believed to contain the secrets of the universe, making it another repository of universal knowledge. Option (a) is incorrect because while rumors abound that the Codex has mystical powers, Professor Alistair is described as a staunch rationalist who dismisses such claims as superstitions. Option (b) is incorrect because the passage states that the Codex is accessible only to a select few, but it does not indicate that Professor Alistair's knowledge is similarly restricted. Option (c) is incorrect because only





Professor Alistair is described as dismissing claims of superstition, not the Verityville Codex. Hence, (d) is correct.

Option (c) is incorrect because, although it captures the idea of change and constancy, it doesn't specifically highlight the town's commitment to intellectual pursuits and wisdom, which are central themes in the passage. Option (d) is incorrect because the passage describes the quest for wisdom in Verityville as "timeless," contradicting the idea that it is "as ephemeral as the morning dew." Hence, (b) is correct.

#### 42. Ans: (b)

Sol: Option (b) is correct because the passage states that the main focus of the annual "Festival of Wisdom" is the "Symposium of the Sages," a panel discussion featuring the brightest minds in various fields, moderated by Professor Alistair. This information is provided in Statement II, making it sufficient to answer the question about the main focus of the festival. Option (c) is incorrect because Statement I alone is not sufficient to answer the question about the main focus of the festival. Option (d) is incorrect because Statement II alone is sufficient to answer the question, making this choice incorrect. Hence, (b) is correct.

#### 43. Ans: (b)

Sol: Option (b) is correct because the passage states that Ms. Eleanor manages the Verityville Library and has an encyclopedic knowledge of literature. This information is provided in Statement II, making it sufficient to answer the question about Ms. Eleanor's main role in Verityville. Option (d) is incorrect because Statement II alone is sufficient to answer the question, making this choice incorrect. Hence, (b) is correct.

#### 44. Ans: (b)

This information is provided in Statement II, making it sufficient to answer the question about the main activity that takes place during the salon. 



According to the passage, the Kerala High Court granted divorce in the case involving marital rape because they considered marital rape to be an act of cruelty, even though it is not penalized in India. This is clearly mentioned in the last few lines of the first paragraph. Hence (c).

#### 110. Ans: c

Sol: Option (c) is correct. The last paragraph emphasizes the need to challenge the idea that women are considered property in marriage. The phrase-ideology of "women being men's chattel", implies the same and thus the paragraph supports women's rights. Hence (c).

## 111. Ans: (b)

Sol: Option (b) is correct. The passage highlights the problem of marital rape and discusses the need for societal challenge. Option (c) suggests addressing the issue through education and awareness, which aligns with the passages' theme of promoting women's rights and autonomy. Hence (b).

#### 112. Ans: a

Sol: Option (a) is correct. The passage mentions that the Kerala High Court recognized marital rape as an act of cruelty and granted divorce, even though it is not penalized in India. It also discusses the Indian government's stance in favor of maintaining the exception for married men in Section 375 of the IPC. Therefore it can be logically deduced that the Kerala High Court's judgment is consistent with the government's stance, as mentioned in option (a). Hence (a).

#### 113. Ans: b

Sol: Option (b) is correct. According to the passage, the government believes in protecting the sacred institution of marriage and has no intentions of discontinuing the exception for married men, as mentioned by the Minister of State for Home Affairs, Haribhai Parathibhai Chaudhary, in response to a question raised in the Rajya Sabha. This means that according to the government's perspective, sexual intercourse between a husband and a wife, even without her consent, is not considered rape under Indian law due to the exception.

## 114. Ans. (b)

Sol. The correct option is (b). Vidhi can make the argument that the government will not necessarily interfere with personal laws as the public considers marriage as a sacred institution. Hence, option (b) is correct. Options (a) and (c) are vague and not expressed in the passage, hence they must be rejected.

#### 115. Ans. (c)

Sol. The correct option is (c). The author notes that the government is not likely to interfere in marriage related personal laws out of fear of offending the institution of marriage. Hence, option (c) highlights this and is the best option. Option (a) is vague whereas Option (b) does not reflect a true statement. Hence, they must be rejected.

## 116. Ans. (b)

Sol. The correct option is (b). The passage provides that in *Independent Thought v. Union of India* in 2017 delivering a prospective judgment, raised the age of consent from 15 to 18 and the apex court held that irrespective of her marital status, a girl child below 18 years of age is incapable of giving consent for sexual intercourse. The judgment does not have the retrospective application therefore it cannot be said to have applied in the present case. In the present case the provision as provided before this judgment would apply wherein the age provided was 15. Since Vidhi had surpassed that age, Vidhan would get the protection of the exception.

#### 117. Ans. (d).





Sol. The correct option is (d). All of the statements mentioned find expression in the passage as true statements which the author uses to extrapolate on the Kerala High Court judgment.

## 118. Ans. (c)

Sol. The correct option is (c). According to the passage, the author notes that just because the Legislatures do not recognize the act of marital rape does not preclude its happenings. Further, the Kerala High Court judgment has paved the way for marital rape to be considered as ground for divorce under cruelty. Author also states that society still views women as men's chattel and hence, both statements would buttress the argument for removing the exclusion of husband under Section 375, IPC.

#### 119. Ans: a

Sol: Option (a) is correct. it should be 'The Kerala High Court in contrast to the general law of India <u>delivered a landmark judgment</u> that deemed marital rape to be a valid ground for divorce.' The phrase is 'deemed to be 'instead of deemed as'. The rest of the sentences are correct ones.

#### 120. Ans: d

Sol: Option (d) is correct. Sentence (i) is a Fact, as it can be verified whether the bench held to its opinion or not, irrespective of what the opinion / judgement is. Sentence (ii) is an Inference. The former half of the sentence is what matrimony is considered to be, hence a fact (generalized) and the latter half of the sentence is an opinion stating what might happen if the changes are made. Hence the sentence becomes an Inference. Sentence (iii) is a Judgement as it states the author's opinion. Sentence (iv) is an Inference giving the reason for the preference made by the government. Hence (d).

## 121. Ans. a

Exp. Union Environment, Forest, and Climate Change Minister Bhupender Yadav announced the results of the Swachh Vayu Sarvekshan 2023 (clean air survey).
